Dear President Andrew Petter and Organizer of the TSSU;

Re: guard.me international health insurance

The Graduate Student Society (GSS) at SFU recently tasked studentcare.net/works with conducting a survey of GSS members in order to obtain information and feedback about our GSS extended benefit plan in particular, but also, about our organization and the experience of graduate students at SFU more generally. We did so to better assist our GSS Executive in determining the level of graduate student satisfaction with our extended benefit plan and to direct our efforts in the coming year.

The survey was conducted from 29 October to 21 November 2014 by telephone interviews, each lasting approximately 10-12 minutes. A random sample of approximately 2800 names was generated by SFU Student Services and provided to studentcare.net/works as a list of graduate students eligible for our extended benefit plan. The sample included graduate students who are enrolled in the plan as well as those who have opted out of the plan by providing proof of an alternate coverage. We were anticipating a sample of 300 graduate students, but some 419 participated. This gave us a margin of error of +/-4.6% against the Fall 2014 graduate student population of 4403. This is an acceptable margin of error as the objective of the survey is to observe general trends and to look for potential areas of concern. In either case, even the most extreme deviation possible (within +/-4.6%) will not alter the conclusion that would be derived from the data. For example, the difference between whether 90.5% or the actual of 95.1% of respondents think that the GSS should continue to provide extended benefits would not alter the conclusion that there is a high level of importance of the plan among graduate students at SFU.

Of those who participated in the survey, 138 were international graduate students (93 skipped this question). While we were surprised by this disproportionally high response rate (the Fall 2014 IRP reports

Furthermore, only 12.3% (or, 17/138) of them have made a claim to Guard.Me and been reimbursed; two respondents have a claim pending. We take this to indicate, on the one hand, that our international graduate students are not well-informed of their medical coverage and related processes; and that few of them are finding Guard.Me valuable, perhaps more importantly on the other.

We understand that the TSSU has filed a grievance with Simon Fraser University and will go to an arbitration hearing this first week of December 2014 to address the exorbitant cost of the Guard.Me program. We believe that the results of our survey are integral to such a discussion and have attached the four pertinent graphs to this letter for details. We would be happy to share a copy of the full report on request.
